

## Merrick County Board Minutes



## November 22, 2016

The Merrick County Board of Supervisors met Tuesday, November 22, 2016 at 9:05 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Graves, Kucera, Weller, Kreachbaum, Carlson, and Wiegert present. Helgoth was absent. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and on the Merrick County website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:05 a.m.

Moved Kucera, second Graves to convene as Board of Supervisors at 9:05 a.m. Roll Call: All Ayes.

**Agenda:** Moved Carlson, second Weller to approve the agenda as presented. Roll Call: All Ayes.

**Minutes**: Moved Kucera, second Weller to approve the minutes of the November 22, 2016 meeting. Roll Call: All Ayes.

**Meeting reports**: Carlson met with Extension Educator Tammy Stuhr and Eagle Communications; Graves, Weller, & Carlson met with Sheriff Westman and the City about jail operations; Graves attended a NIRMA meeting, hospital meeting, & Senior Center meeting; Kreachbaum attended the Midland Area on Aging and Kreachbaum, Wiegert, and Graves went out to the County Shop to look at the new grader.

Official's reports: Extension Educator Stuhr showed a picture of the donor board to the Board. She said the 4H Building Contractors meeting will be November 29<sup>th</sup> at 10:00 a.m. Chase Samuelson placed 17<sup>th</sup> at the National 4H Livestock Skillathon Contest in Kentucky. They are taking nominees for the Extension Board. Steve Melvin is the new Ag Educator and will start on December 1, 2016. Planning and Zoning Myers gave the Board a copy of the building permits and went over the Wind & Solar Conference she attended in Lincoln with the Board. Sheriff Westman said the Fire Marshall's report did not contain much. They will need a fire sprinkler system in the laundry room and a door between the laundry room and the kitchen.

**Hospital update**: Julie Murray gave a brief hospital update to the Board and gave them an overview of the acquisition of the hospital to Bryan Memorial. The CEO of Bryan was also present as well as Paul Clarke to answer questions and concerns. The current hospital building would remain as a county asset. Long Term would remain in tack with management being under Good Samaritan.
