



September 12, 2017

The Merrick County Board of Supervisors met Tuesday, September 12, 2017 at 9:05 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Graves, Kreachbaum, Carlson, Kucera, Weller, Helgoth, and Wiegert present. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and on the Merrick County website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:05 a.m.

Moved Kucera, second Graves to convene as Board of Supervisors at 9:05 a.m. Roll Call: All Ayes.

Agenda: Moved Carlson, second Weller to approve the agenda as presented. Roll Call: All Ayes.

Minutes: Moved Helgoth, second Weller to approve the minutes as published from August 22 and August 25, 2017. Roll Call: Ayes: Kreachbaum, Kucera, Helgoth, Carlson, and Graves was Aye on August 22, 2017 but abstained on the August 25, 2017 minutes.

Meeting Reports: Graves had NIRMA meeting August 24 and 25th, Safety meeting on September 7 and a personnel meeting on September 8; Graves, Carlson, Helgoth and Wiegert attended the groundbreaking for Preferred Popcorn; Kreachbaum attended the Mid Plains meeting on August 28, Kreachbaum and Wiegert attended the 4H Overseers meeting on September 6; Kucera attended the personnel meeting regarding Planning & Zoning, Extension Board meeting. Kucera said that Graves had spoken to the City of Central City about combing their Planning & Zoning with the County but they are not ready to do that, so the committee asked Carlson to look into going in with Hamilton County. Wiegert attended the Midland Area on Aging meeting on September 7, 2017.

Official's report: Highway Superintendent Meyer said that they had looked into rodent control for the County Shop and it would cost \$150.00 every six months with the same company that does the courthouse. This expense will come out of the Building & Grounds budget. The Planning & Zoning email will be forwarded to the Highway Department or so that Myers and Meyer can both see the emails until Myers last day on September 15. The Board said that Highway Superintendent Meyer could take care of the Zoning meeting on September 28 and would be appointed the temporary Planning & Zoning at the next Board meeting until someone was hired.

Water issues: Ray Hubda discussed with the Board water flooding on his property and the Board said that Highway Superintendent Meyer would look at it and that Hubda should also contact the NRD about this matter.

RESOLUTION 2017-20: Moved Graves, second Kreachbaum to approve RESOLUTION 2017-20 adopting the Central Platte NRD Hazard Mitigation Plan to qualify as a participant in the Lower Loup NRD Hazard Mitigation Plan Update and be eligible for project grant funding to assist with implementation of actions in the plan. Roll Call: All Ayes. RESOLUTION 2017-20 is on file in the County Clerk's Office for public viewing.

Electrical Agreement: Moved Kucera, second Helgoth to approve the electrical agreement for Lanny & Jewell Faeh to install electric lines in conduit for grain bins between Sections 17 & 8, Township 13, Range 7. Roll Call: All Ayes. **Electrical Agreement**: Moved Kucera, second Weller to approve the electrical agreement for Jason Hanke to have Southern Power bury underground wire to an irrigation well and remove overhead lines and anchors between Section 25 & 36, Township 14, Range 8. Roll Call: All Ayes.

Riverside Park Road: Edwin Eilts told the Board he would like to see the ½ mile of gravel road that runs in front of his home black topped. This road Eilts said is very heavily traveled and was a hard road to maintain. Graves and Highway Superintendent Meyer said that part of this road is in the City's jurisdiction. Meyer said he would talk to Chris Anderson about this.

Wellness Connection Program: There was no response from the County employees regarding the Wellness Connection Program offer by the hospital. Kucera said that Wellness Partners, who have come out for the last couple of years was wanting to come again so Kucera will contact them and have them come again at no cost to the County.

1% increase in restricted funds: Moved Graves, second Carlson to approve the 1% increase in restricted funds authority for the 2017-2018 fiscal year. Roll Call: Carlson, Graves, Kreachbaum, Kucera, Helgoth, Weller, and Wiegert. RESOLUTION 2017-21: Moved Helgoth, second Graves determining a final allocation of levy authority to political

subdivisions. Roll Call: All Ayes. **Budget hearing**: Moved Kucera, second Graves to open the budget hearing at 10:30 a.m. to hear support, opposition, priting an absorbations of townsylves relating to the 2017 2018 fined year hydrot at 10:30 a.m. Poll Call

criticism, suggestions or observations of taxpayers relating to the 2017-2018 fiscal year budget at 10:30 a.m. Roll Call: All Ayes. Accountant Mitch Inman with Dana F Cole informed the Board that 23.6314 was last year's tax rate and this year's tax rate is 23.6324 or 1/1000th of a cent difference. Inman took \$33,000.00 from the tax reserve to get the levy





within the 1/1000th. Jan Placke read a letter she had prepared to the Board regarding the spending of tax dollars. Moved Kucera, second Graves to close the hearing at 10:46 a.m. Roll Call: All Ayes.

Final tax request hearing: Moved Kucera, second Carlson to open the hearing to set the final tax request for fiscal year 2017-2018 at 10:47a.m. Roll Call: All Ayes. Moved Kreachbaum, second Carlson to set the final tax request for fiscal year 2017-2018 at \$4,362,000.00. Roll Call: All Ayes. Moved Kucera, second Gravse to close the hearing at 10:52 a.m. Roll Call: All Ayes.

Appraisal maintenance service: Moved Kucera, second Carlson to accept the bid from Stanard Appraisals for 24 days for \$18,240.00 per year and any additional hours over 192 will be billed at \$95.00 an hour for appraisal maintenance service. Roll Call: All Ayes.

Appraisal review: Moved Kucera, second Graves to accept the bid from Stanard Appraisals for \$5,000.00 for appraisal review of all active gravel/sand pits and the remaining land after mining in Central City. Roll Call: All Ayes.
