



Merrick Board of Equalization Minutes



March 8, 2016

The Merrick County Board of Equalization met Tuesday, March 8, 2016 at 9:00 a.m. in the Supervisors Room, County Courthouse, Central City, NE, with Graves, Kucera, Carlson, Weller, Helgoth, Kreachbaum and Wiegert present. County Attorney Homolka was also present.

Notice of the meeting was given thereof by publications in the Republican Nonpareil and The Palmer Journal and the Merrick County Website. Proof of publication is filed in the Clerk's Office. Copies of the agenda were mailed to each Supervisor and kept current and available to the public at the County Clerk's Office.

Chairman Wiegert declared the meeting was preceded by publicized notice and having acknowledged and identified the location of the posting of the current copy of the Open Meetings Act, called the meeting to order and in open session at 9:00 a.m.

Exemption hearing: Moved Kucera, second Graves at 9:03 a.m. to open the permissive exemption hearing for the Central City Sportsmen's Club and the Clarks VFW. Roll Call: All Ayes. Bob Davis representing the Central City Sportsmen's Club said they were going to withdraw their application for exemption. Bill Wurtz representing the Clarks VFW said they were not opposed to a partial exemption. Moved Graves, second Kreachbaum to close the hearing at 9:12 a.m. Roll Call: All Ayes. Moved Helgoth, second Carlson to rescind their original motion to exempt the Central City Sportsmen's Club. Roll Call: All Ayes. Moved Helgoth, second Weller to rescind their original motion to exempt the Clarks VFW and now to make it a partial exemption. Roll Call: All Ayes.

Taxation Protest: Moved Weller, second Graves to go with the Assessors recommendation to make parcel 3592.00 for Central City Schools District 4 exempt. Roll Call: All Ayes.

Tax Correction: Moved Weller, second Graves to approve tax correction #3716 for Agco Finance, LLC to correct taxes on equipment that was also reported on Personal Property Schedule 1610. Roll Call: All Ayes.
